The Mills Soil Conservation District hereby states:

- (1) The Mills Soil Conservation District has entered into agreements with landowners under section 467A.7(16), Iowa Code.
- (2) There are in effect in Mills County certain agreements covenanted under section 467A.7(16), Iowa Code, which place upon owners of agricultural land the obligation to maintain permanent soil conservation practices established with public cost-sharing money, and failure to do so may result in an obligation to refund a portion of the public cost-sharing money used to establish the practices.
- (3) Section 467A.7(16), Iowa Code, as amended by Laws of the 68th G.A., 1980 Sess., ch. 1153, § 3, specifically provides that the agreement to refund shall not create a lien on the land but shall be a charge personally against the owner of the land at the time of removal, alteration, or modification which gives rise to the need for a refund. Under this statute, the District need not record the specific agreements in order to transfer this obligation to a subsequent owner of the land.
- (4) These agreements are on file at the office of the Mills Soil Conservation District, located at (Address) 313 Main St. Malvern and may be viewed there during regular office hours (Monday through Friday from 8:00 a.m. to 5:00 p.m.)
