**DECLARATION OF EASEMENT**

This Declaration of Easement is made this 25 day of August, 1998, by Ted Grace Development, L.L.C., a Nebraska Limited Liability Company.

The Easement shall run in favor of the City of Omaha as part of the Linear Trail Corridor and is given pursuant to the terms of the Subdivision Agreement dated as of January 26, 1998, by and among Declarant, Sanitary and Improvement District No. 422 of Douglas County and the City of Omaha, Facilities developed within the Easement shall be limited to: trail paths, landscaping, boundary fencing, signage, lighting, utilities and parking areas.
4. This Easement shall run with the title to the land. Neither Declarant nor its successors and assigns with respect to the Real Estate shall construct any improvements within the Easement other than for the purposes stated above.

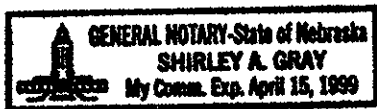

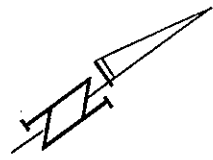
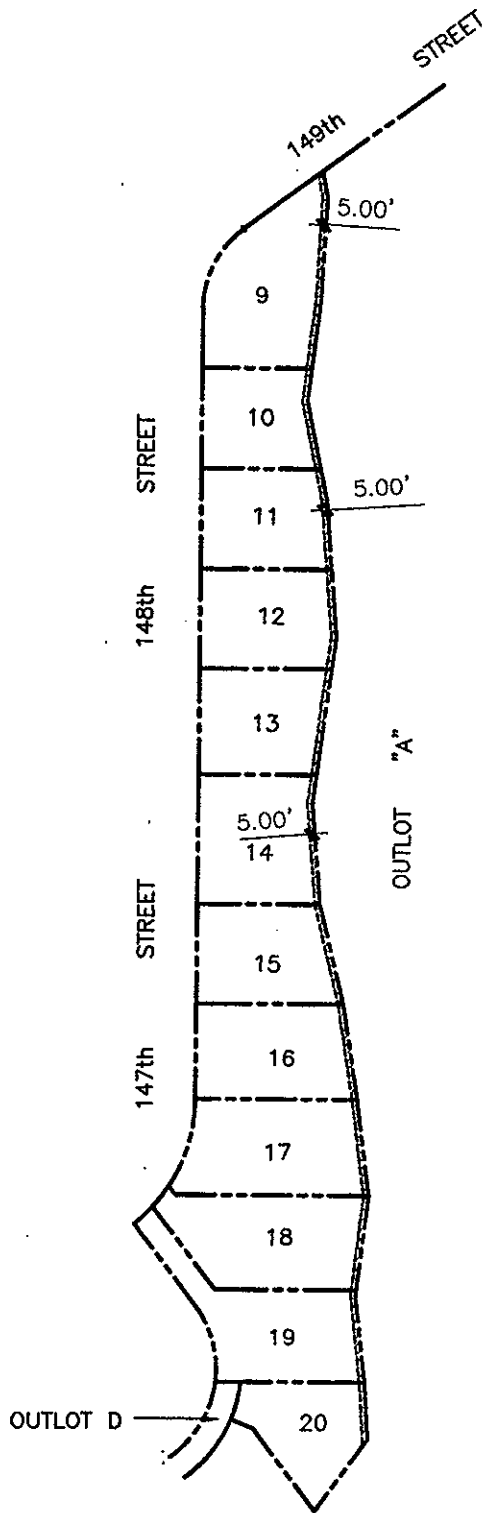
