Tract "I": R.O.W. Acquisition. A parcel of land located in part of the SE 1/4 of Section 18, T78N, R4E of the 5th P.M., Scott County, Iowa, more particularly described as follows:

Commencing at the NW corner of the SE 1/4 of said Section 18; thence S.01046'54"E. along the west line of said SE 1/4 a distance of 744.00 feet; thence N.88013'06"E. a distance of 30.00 feet to the Point of Beginning, said P.O.B. being on the existing easterly right-of-way line of Jersey Ridge Road; thence S.01046'54"E. along said right-of-way line a distance of 209.00 feet; thence N.88013'06"E. along said right-of-way line a distance of 5.50 feet to the intersection with the new easterly rightof-way line of Jersey Ridge Road; thence N.01046'54"W. along said new easterly right-of-way line a distance of 209.00 feet; thence S.88°13'06"W. a distance of 5.50 feet to the Point of Beginning.

Tract "II": Temporary Grading and Construction Easement. A parcel of land located in part of the SE 1/4 of Section 18, T78N, R4E of the 5th P.M., Scott County, Iowa, more particularly described as follows:

A strip of land being 10 feet in width lying easterly of and adjoining the above described Tract I.

The temporary easement shall terminate when the City approves and accepts said project or on September 1, 1996, whichever is earlier.

This Right-of-Way and easement is conveyed upon the following express understandings and conditions that on the completion of any and all construction work by the City of Davenport, the affected real estate shall be restored by the City to substantially the same condition it was in prior to such work, except for the removal (and replacement thereof) of 836 square feet of sidewalk and the projected changes in use, sloping, grading and changes in grade to the temporary easement area. It is also understood that the City shall assure responsibility of paving the fifth lane of Jersey Ridge Road adjacent to said Owner's property conveyed above, which releases said Owner's responsibility per a 1988 street construction agreement with the

City. The City of Davenport shall also guarantee to Weerts

Funeral Home and the general public the ability to ingress and

egress said Owner's property at all times. All denuded areas

will be sodded by the City's contractor.

Owner shall have five (5) years from the date of this document to renegotiate construction or maintenance damages not apparent at the time this document is signed.

Owner covenants that it holds the above described real estate by title in fee simple, that it has good and lawful authority to sell and convey the same, and that it will warrant and defend the real estate against the lawful claims of all persons whomsoever.
