GRANT OF EASEMENTS

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, SHEILA J. STILES, a widow ("GRANTOR") is the owner of the following described property upon which the VILLAGE of WATERLOO, Douglas County, Nebraska ("GRANTEE") is the grantee of an easement ("EASEMENT") pursuant to which the U.S. Army Corps of Engineers ("CORPS") constructed a Flood Control Project ("FCP") in 1967;

WHEREAS, the GRANTEE is responsible for maintaining the FCP;

WHEREAS, the Federal Emergency Management Agency ("FEMA") has determined that the FCP no longer complies with FEMA's freeboard requirements in order to provide 100-year flood protection for the VILLAGE;

WHEREAS, in order to comply with FEMA's requirements certain modifications of the FCP will be required and certain additions to said EASEMENT will be required; and

WHEREAS, GRANTORS are willing to grant additions to said EASEMENT to permit the modifications in the FCP in order to comply with FEMA's freeboard requirements.

NOW THEREFORE, In consideration of the payment of \$10.00 and other good and valuable consideration, GRANTORS does hereby grant and convey to GRANTEE, and to its successors and assigns, rights, privileges and Easements over, through and across the following described properties:

PERMANENT EASEMENT #1:

The location and description of said Permanent Easement is shown on Exhibit "A" which is attached hereto and incorporated herein.

Said Permanent Easement will commence upon the execution of this Grant of Easements and will continue in full force and effect for so long as said FCP exists.

TEMPORARY CONSTRUCTION EASEMENT #1:

The location and description of said Temporary Easement is shown on Exhibit "A" which is attached hereto and incorporated herein.

Said Temporary Construction Easement will commence at the time construction of improvements to the FCP begins and will terminate following completion of the construction work.

GRANTOR, for itself if successors and assigns, warrants to GRANTEE, its successors and assigns, that GRANTOR is the owner of the property shown on Exhibit "A", that GRANTOR has authority to grant the aforesaid Easements, and that said Easements are free and clear of encumbrances.

TO HAVE AND TO HOLD unto GRANTEE its successors and assigns, the rights, privileges and easements to construct modifications to the existing FCP and trail on, across, and through the Permanent Easement described above, together with the GRANTEE's and the public's rights of use, ingress to, and egress from said Permanent Easement.
