- Esther P. Donahoo died on June 27, 2001. 2.
- I am the named devisee of a specific bequest under Article 4 of the will of Esther P. Donahoo, dated 3. November 15, 2000 which was informally admitted to probate in this Court on July 25, 2001.
- Article 4 of the will concerned property whose legal description is attached as Exhibit A to this disclaimer. That portion of the property which is legally described below is what I intend to disclaim:

An undivided one-third interest in the following property:

The West Half of the Southeast Quarter (W1/2 SE1/4) of Section 2: and

the Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4) of Section 2 except a strip of land along the South side thereof 37.62 feet wide;

All of the above property is located in Township 14 North, Range 10, East of the 6th P.M., in Douglas County, Nebraska.

- Esther P. Donahoo died while a resident of Douglas County, Nebraska. 5.
- I have not accepted any of the benefits of the property described in paragraph 4 of this Renunciation 6. and Disclaimer.
- I have not received any of funds from the property described in paragraph 4 of this Renunciation and 7. Disclaimer.
- 8. I intend to renounce and disclaim any interest in the property described in paragraph 4 of this Renunciation and Disclaimer.
- I declare that this renunciation and disclaimer shall be an irrevocable and unqualified refusal to accept the property described in paragraph 4 of this Renunciation and Disclaimer.

10. Nothing in this Renunciation and Disclaimer shall be treated as an acceptance of, a renunciation of, or a disclaimer of any devise in the will of Esther P. Donahoo except for the property described in paragraph 4 of this Renunciation and Disclaimer. I intend to retain all other real estate given to me under the will of Esther P. Donahoo except for that real estate legally described in paragraph 4 above.

I, Gloria J. Bartels, now state that I unqualifiedly and irrevocably renounce and disclaim any interest in the property described in paragraph 4 of this Renunciation and Disclaimer. This renunciation and disclaimer is made under Nebraska Probate Code §30-2352 and §2518 and §2046 of the Internal Revenue Code of 1986. I further state that this renunciation and disclaimer is made within the times prescribed under those provisions of law.
