

RESTRICTIVE COVENANTS AND CONDITIONS

The undersigned, James C. Emmert and Dorothy S. Emmert, husband and wife, and David E. Beber and Arlene D. Beber, husband and wife, being the owners of:

Lots One (1), Two (2), Four (4), and Five (5), and Lot Three (3), except the North 150 Ft. of said Lot Three (3) and except the West 120 Ft. of the South 150 Ft. of said Lot Three (3), all in Block Five (5), in Rockbrook Heights, an addition in Douglas County, Nebraska, as surveyed, platted, and recorded,

do hereby state, declare and publish that all of said described real estate, except the East 120 Ft. of the South 100 Ft. of said Lot Three (3), shall be owned, conveyed and used under and subject to the restriction and condition that no part of said first described real estate, except the said East 120 Ft. of the South 100 Ft. of Lot Three (3), may be used for the operation of any business that is engaged exclusively in the preparation of and/or sale of bakery products.

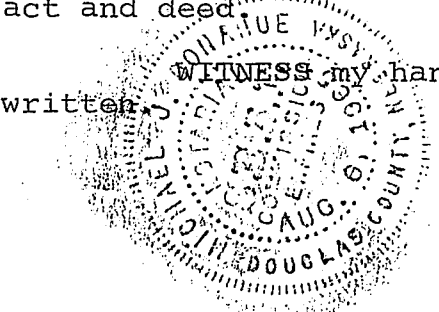
