ARTICLE I IDENTIFICATION OF FAMILY

ARTICLE II PAYMENT OF DEBTS AND EXPENSES

ARTICLE III DISPOSITION OF PROPERTY

A. Specific Bequests. I direct that the following specific bequests be made from my estate.



- C. <u>Residuary Estate</u>. I direct that my residuary estate be distributed to Nancy Mandolfo, Las Vegas, Nevada. If such beneficiary does not survive me, my residuary estate shall be distributed to Michelle Mandolfo, Omaha, Nebraska. If such beneficiary does not survive me, my residuary estate shall be distributed to the following beneficiaries in the percentages as shown:
 - 100% Nancy Mandolfo, Las Vegas, Nevada. If this person does not survive me, this share shall be distributed to Michelle Mandolfo, Omaha, Nebraska.
 - 100% Michelle Mandolfo, Omaha, Nebraska. If this person does not survive me, this share shall be distributed to Machala <u>Danieri</u>, Las Vegas, Nevada.
 - 100% Machala Danieri, Las Vegas, Nevada. If this person does not survive me, this share shall be distributed proportionately to the other distributee(s) listed under this provision.

ARTICLE IV NOMINATION OF EXECUTOR

I nominate Nancy Mandolfo, of Las Vegas, Nevada, and Michelle Mandolfo, of Omaha, Nebraska, as Co-Executors (the "Executor"), to serve without bond, surety, or other security. If one (or both) of the above nominees does not serve for any reason, I nominate Machala Danieri, of Las Vegas, Nevada, as replacement Co-Executor (or sole Executor), to serve without bond, surety, or other security.

ARTICLE V EXECUTOR POWERS

- A. <u>Power to Administer Estate</u>. My Independent Executor, with respect to my estate, in addition to other powers and authority granted by law or necessary or appropriate for proper administration, shall have the following rights, powers, and authority without order of court and without notice to anyone:
 - 1. Independent Administration. My Independent Executor shall have the right to administer my estate using "informal", "unsupervised", or "independent" probate or equivalent legislation designed to operate without unnecessary intervention by the probate court.

ARTICLE VI SPECIAL DIRECTIVES

I, hereby state, that in addition to the directives and bequests as set forth in this Will, it is my desire and wish to include the following special directives and last wishes: to have my remains cremated and ashes distributed in my special places. I want a memorial service, not a religious service.

ARTICLE VII MISCELLANEOUS PROVISIONS

- A. <u>Paragraph Titles and Gender</u>. The titles given to the paragraphs of this Will are inserted for reference purposes only and are not to be considered as forming a part of this Will in interpreting its provisions. All words used in this Will in any gender shall extend to and include all genders, and any singular words shall include the plural expression, and vice versa, specifically including "child" and "children", when the context or facts so require, and any pronouns shall be taken to refer to the person or persons intended regardless of gender or number.
- B. <u>Thirty Day Survival Requirement</u>. For the purposes of determining the appropriate distributions under this Will, no person shall be deemed to have survived me unless such person is also surviving on the thirtieth day after the date of my death.
- C. Liability of Fiduciary. No fiduciary that is a natural person shall, in the absence of fraudulent

conduct or bad faith, be liable individually to any beneficiary of my estate, and my estate shall indemnify such natural person from any and all claims or expenses in connection with or arising out of that fiduciary's good faith actions or non-actions of the fiduciary, except for such actions or non-actions which constitute fraudulent conduct or bad faith. No successor trustee shall be obliged to inquire into or be in any way accountable for the previous administration of the trust property.

- D. <u>Compensation</u>. The Executor is entitled to receive reasonable compensation for their services under this Will and be exonerated from and to pay all reasonable expenses and charges of the estate and trust.


