



WARRANTY DEED - Corporation - Street Purposes

THIS DEED, Made this 18th day of April, A.D., 1966, between NATHAN COMPANY

a corporation organized and existing under and by virtue of the laws of the State of Nebraska, party of the first part, and the City of Omaha, a Municipal Corporation organized and existing under (and by virtue of) the laws of the State of Nebraska,

WITNESSETH: (That the said party of the first part for and in consideration of the sum of ~~two thousand~~ and other good and valuable consideration in hand paid, receipt of which is hereby acknowledged, has sold and by these presents does grant, convey and confirm unto the said City of Omaha for street purposes the following described premises, situated in Douglas County, and State of Nebraska, to-wit:

A tract of land situated in the Southwest Quarter (S.W.1/4), Section thirty-six (36), Township fifteen (15) North, Range twelve (12) East of the Sixth Principal Meridian (6th P.M.), in the City of Omaha, Douglas County, Nebraska, as surveyed, platted and recorded, more particularly described as follows: Commencing at a point thirty-three point zero (33.0) feet North and thirty-three point zero (33.0) feet East of the Southwest corner of said Section thirty-six (36); thence North along the East line of 72nd Street, a distance of Five hundred thirty-five (535) feet; thence East a distance of twenty-nine point zero (29.0) feet; thence Southwesterly to a point One hundred ninety-

And the said party of the first part for itself and its successors, does hereby covenant and agree to and with the said City of Omaha, and its successors and assigns, that at the time of the execution and delivery of these presents it is lawfully seized of said premises; that it has good right and lawful authority to convey the same; that they are free from encumbrance; and party of the first part does hereby covenant for itself and its successors to warrant and defend the said premises against the lawful claims of all persons whomsoever.
