## RELEASE OF EASEMENTS

WHEREAS, utility easements were retained in the ordinances vacating those streets and alleys described in Exhibit A attached hereto and incorporated by reference herein; and

WHEREAS, the ordinances, Ordinance #24190 passed by the City Council on February 28, 1967, Ordinance #28714 passed by the City Council on May 8, 1979, Ordinance #29047 passed by the City Council on February 5, 1980, Ordinance #28715 passed by the City Council on May 8, 1979, Ordinance #26565 passed by the City Council on October 17, 1972, Ordinance #29934 passed by the City Council on February 22, 1983, and Ordinance #33115 passed by the City Council on December 7, 1993, have been recorded in the Register of Deeds office in Book 447 at Page 409, Book 615 at Page 24, Book 629 at Page 306, Book 615 at Page 26, Book 515 at Page 561, Book 685 at Page 173, and Book 1109 at Page 586, respectively; and,

WHEREAS, the property owner has requested release of the easements reserved in said Ordinances to permit better use of the property; and,

WHEREAS, no sewer lines or other facilities exist in these right-of-ways, except as provided below, and the Public Works Department has no objection to the release of the sewer easements retained in the cited Ordinances; and,

WHEREAS, the release of these easements will not adversely impact the City Master Plan.

NOW, THEREFORE, IN ACCORD WITH THE PROVISIONS OF SECTION 27-1 OF THE OMAHA MUNICIPAL CODE:

The release of the easements retained in Ordinance #24190 passed by the City Council on February 28, 1967, Ordinance #28714 passed by the City Council on May 8, 1979, Ordinance #29047 passed by the City Council on February 5, 1980, Ordinance #28715 passed by the City Council on May 8, 1979, Ordinance #26565 passed by the City Council on October 17, 1972, Ordinance #29934 passed by the City Council on February 22, 1983, and Ordinance #33115 passed by the City Council on December 7, 1993, providing for the vacation of those streets and alleys described in the attached Exhibit A, which were recorded in the Register of Deeds office in Book 447 at Page 409, Book 615 at Page 24, Book 629 at Page 306, Book 615 at Page 26, Book 515 at Page 561, Book 695 at Page 173, and Book 1109 at Page 586, respectively, is approved and the delivery of this release is authorized. 
