AMENDMENT TO EASEMENT AGREEMENT

THIS AMENDMENT TO EASEMENT AGREEMENT ("Amendment") is made this 5 day of June, 1995, by POLING PLACE II, L.L.C., a Nebraska limited liability company ("Poling") and ANTHONY, INC., a Nebraska corporation ("Anthony").

PRELIMINARY STATEMENT

1. Poling is the owner of certain real estate legally described on Exhibit "A" attached hereto and incorporated herein by reference (the "Property").

2. Certain predecessors in title of Poling granted a certain ingress and egress easement to Anthony with respect to a portion of the Property by virtue of that certain Easement Agreement dated May 3, 1994, filed June 8, 1994 in Book 711, Page 681 of the records of Douglas County, Nebraska (the "Easement Agreement"). Poling and Anthony wish to amend the Easement Agreement upon the terms and conditions hereinafter set forth.

NOW, THEREFORE, in consideration of the foregoing Preliminary Statement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Poling and Anthony hereby agree as follows:

1. A new sentence shall be added to the end of paragraph 5 of the Easement Agreement as follows:

"However, should Poling damage the Easement Area so that the Easement Area is not passable for automobile traffic, Poling agrees to make such repairs, at its expense, to the Easement Area with crushed rock/gravel so that automobiles may use the Easement Area".

2. Except as herein amended, the Easement Agreement shall remain in full force and effect and shall be binding upon the parties hereto and their respective successors and assigns.

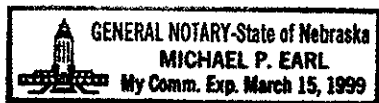
