KNOW ALL MEN BY THESE PRESENTS, That UNITED STATES STEEL AND CARNEGIE PENSION FUND, a corporation organized and existing under and by virtue of the laws of the State of Pennsylvania, for and in consideration of the sum of THIRTY-FOUR THOUSAND SEVEN HUNDRED EIGHTY-TWO AND 60/100 DOLLARS (\$34,782.60), in hand paid does hereby grant, bargain, sell and convey unto UNION PACIFIC RAILROAD COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Utah, grantee, the following described real estate, situated in the County of Douglas and State of Nebraska, to-wit:

An irregular tract of land situate in the East 1/2 of Northeast 1/4 of Section 2, Township 14 North, Range 12 East, of the Sixth Principal Meridian, in Douglas County, Nebraska, more particularly described as follows:
