A tract of land located in the southeast corner of the Northwest Quarter of Section 26, Township 14 North, Range 11 East of the 6th P.M., Sarpy County, Nebraska, described as follows:

Referring to the center quarter corner of said Section 26; thence westerly on the South line of the Northwest Quarter of said Section 26 a distance of 285.4 feet to the point of beginning; thence continuing westerly on said South line a distance of 470.2 feet; thence northeasterly a distance of 990.1 feet, more or less, to a point on the East line of said Northwest Quarter; thence southerly on said East line a distance of 392.2 feet to a point 239.6 feet northerly from the southeast corner of said Northwest Quarter; thence southwesterly a distance of 375.5 feet to the point of beginning, containing 4.70 acres, more or less.

And the said Louise Heuck hereby relinquishes all her rights of every name and kind in and to the above described premises.





