

This Agreement made and entered into this 16th day of November, 1956, by and between Guarantee Mutual Life Company, hereinafter called "Guarantee" and The Malvern Company Inc., hereinafter called "Malvern", Witnesseth:

WHEREAS, "Guarantee" has purchased a tract of land of approximately 11 acres in Indian Hills Village Addition to the County of Douglas, Nebraska, from "Malvern" and has commenced the construction of its Home Office Building on a part of said tract of land, and

WHEREAS, "Guarantee" and "Malvern" are desirous of protecting the appearance development and utility of the sites owned by them to their mutual benefit and advantage, and

WHEREAS, "Guarantee" has contracted with Omaha Public Power District to install electrical service for its use and the subsequent use of "Malvern", through an underground cable running East from 90th Street along Indian Hills Road, and is participating with "Malvern" in the payment of the costs of said installation on condition that "Guarantee" or "Malvern" will never install or allow any poles or pole lines to be installed or maintained for either electric or telephone service, along or upon Indian Hills Drive between 84th and 90th Street in said Indian Hills Village Addition.

IT IS THEREFORE AGREED by and between "Guarantee" and "Malvern" in consideration of \$1.00 and their promises, covenants and agreements, and the installation of Electricity through underground cables and conduits by Omaha Public Power District in accordance with its agreement with "Guarantee", that neither

"Malvern" or "Guarantee" will ever install or allow any poles or pole lines to be installed or maintained for either Electric or Telephone service, along or on Indian Hills Drive between 84th Street and 90th Street in Indian Hills Village Addition to Douglas County, Nebraska.

This Agreement is binding upon the successors, and assigns of the undersigned.

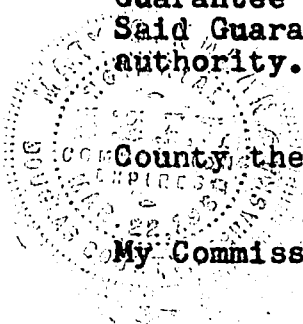
