The undersigned owner(s) of an interest in the real estate described below (Hereinafter called "Owner") hereby grant(s) and convey(s) to NORTHWESTERN BELL TELEPHONE COMPANY, an Iowa Corporation, its associated and allied companies, its and their respective successors, assigns, lessees and agents (Hereinafter called "Company"), in consideration of the sum of Two-Hundred Dollars (\$ 200.00) received from the Company and of the agreements stated below, a right-of-way and easement to construct, operate, maintain, replace, and remove such communications systems as the Company may from time to time require. Said communications systems shall consist of buried cable, conduit, manholes, surface terminals, protective barriers and associated equipment which will be installed, maintained, reinforced or removed as the Company may deem necessary for the purpose of exercising the rights herein granted, upon, under, across and through a plot of land Six (6') feet wide and Six (6') feet long, being a part of the following described real estate located in the County of Douglas, State of Nebraska.
More specifically described as:

A parcel of land six feet (6') wide and six feet (6') long extending six feet (6') north of the south boundary line and six feet (6') east of the west boundary line, containing an area of thirty-six (36) square feet, located in the southwest corner of Lot 2, Indian Hills Village, NE 1/4 of NE 1/4 of Section 22, Township 15, Range 12, Douglas County, Nebraska.

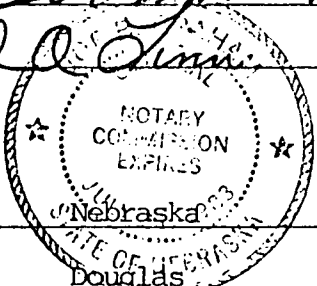

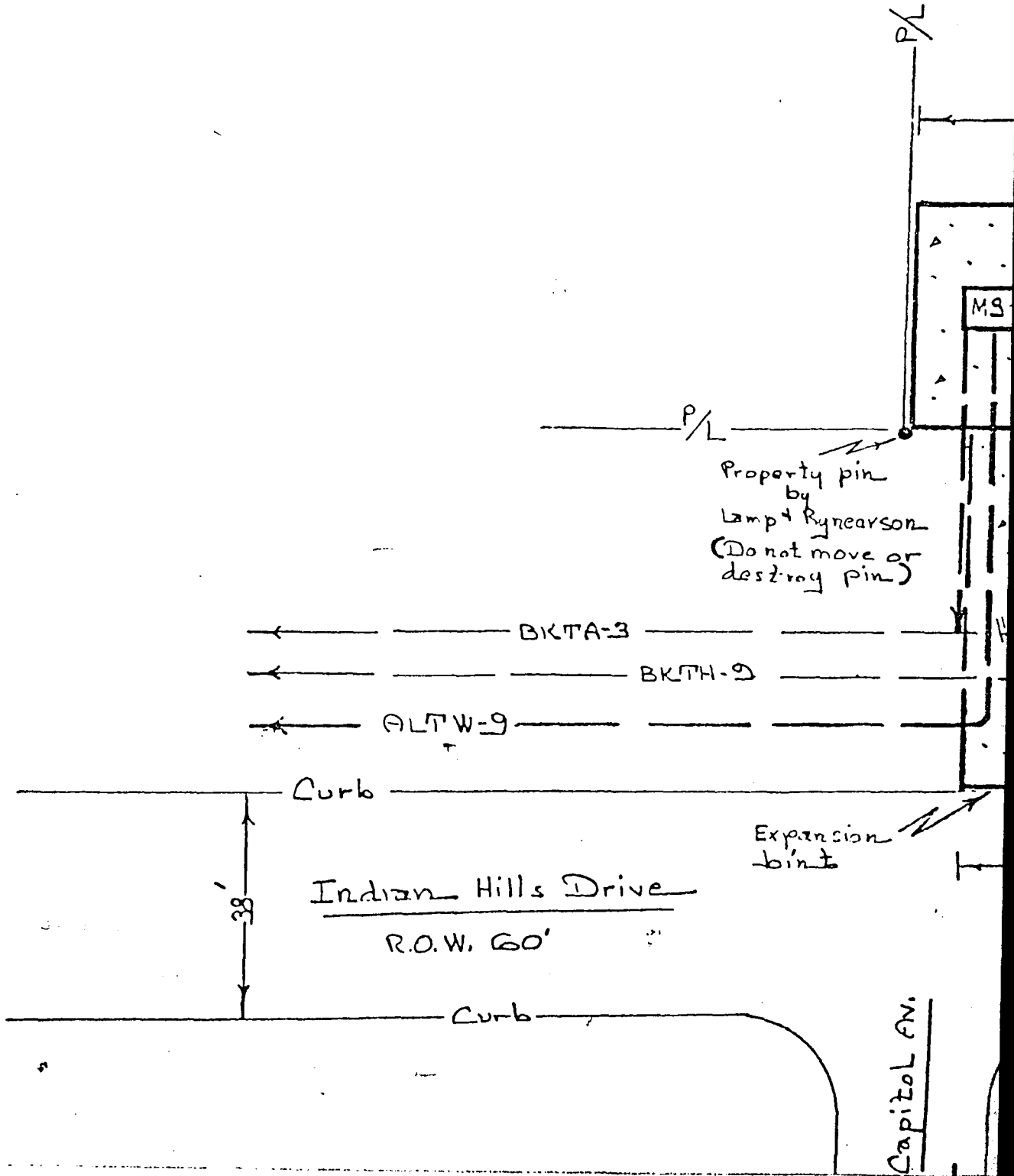

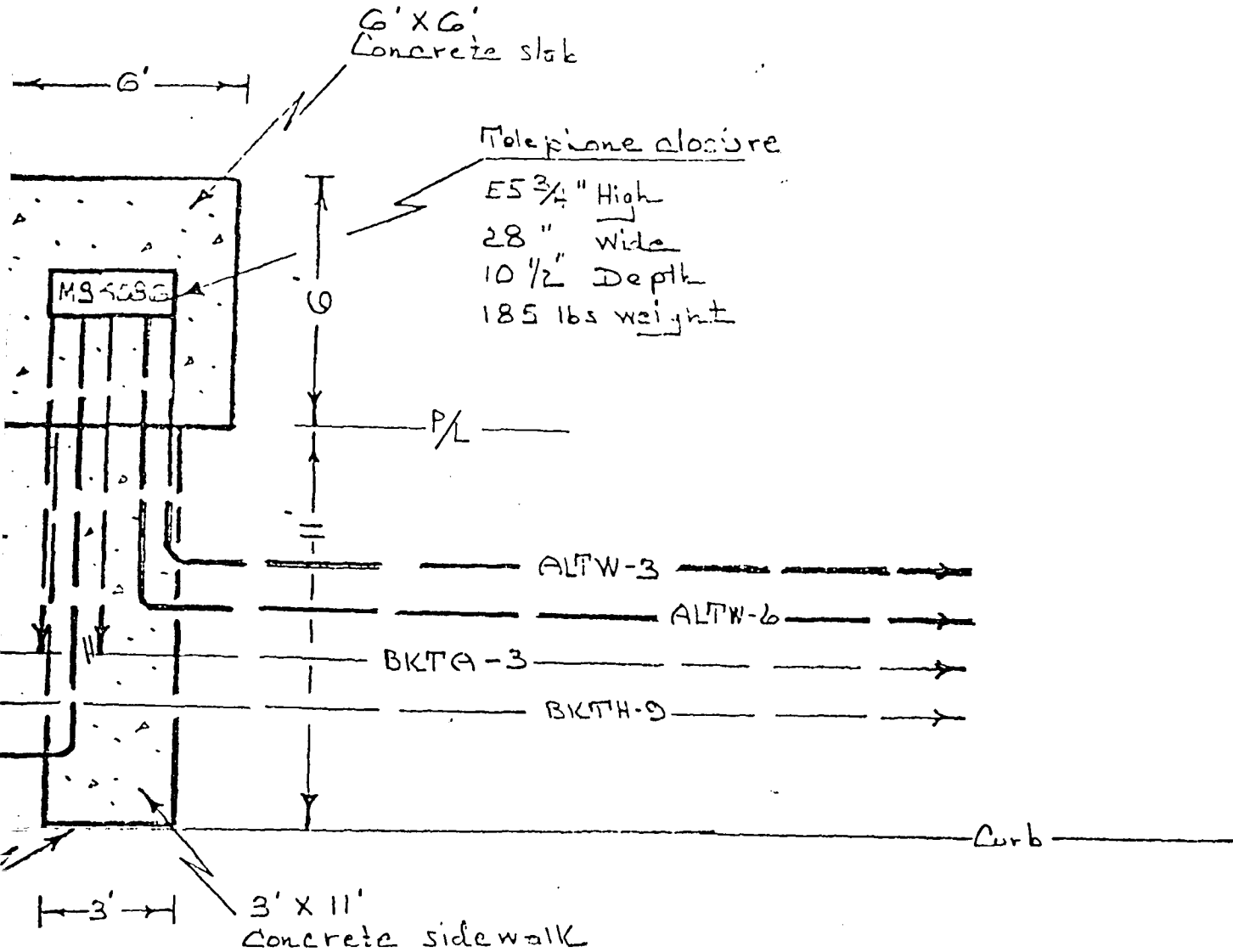
