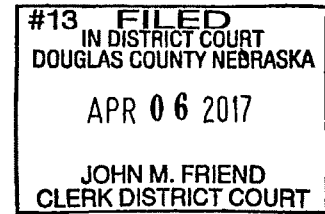

THIS MATTER came on for jury trial on the 11th through the 25th days of October 2016. Jury trial proceeded. Evidence was adduced and exhibits were received into evidence. Jury instructed. The jury, after due deliberation by the jurors, returned a unanimous verdict in favor of the Plaintiffs, Jackson Cuenca, a minor, by and through his parents, Emily Cuenca and John Cuenca., as next friends and natural guardians, and Emily Cuenca, individually, and John Cuenca, individually, as follows: Economic Damages for Jackson Cuenca, \$6,442,000.00; Non-Economic Damages for Jackson Cuenca, \$2,500,000.00; Economic Damages for Emily Cuenca, \$1,828,000.00; Non-Economic Damages for Emily Cuenca \$500,000.00; and Non-Economic Damages for John Cuenca, \$250,000.00, for a total of \$11,520,000.00.

The Court finds that the Nebraska Hospital Liability Act, Neb. Rev. Stat. § 44-2801 et seq. (Reissue 2010) applies to the verdicts reached in favor Plaintiffs, Jackson Cuenca, a minor, by and through his parents, Emily Cuenca and John Cuenca., as next friends and natural guardians, and Emily Cuenca, individually.

Based upon the above and foregoing, it shall be the JUDGMENT of the Court as follows:

1. Judgment is hereby entered in favor of Plaintiff, Jackson Cuenca, and against Defendants, Physicians Clinic, Inc. and Nebraska Methodist Hospital jointly and severally in the total amount of \$1,750,000;



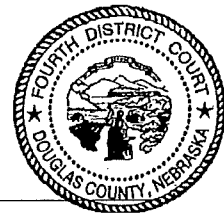

THIS MATTER came before the Court on May 1, 2017 on the following motions:

- a. Plaintiffs' Motion to Alter or Amend Judgment;
- b. Plaintiffs' Motion to Refrain from Ruling and to Expand Discovery; and
- c. Defendants' Motion to Set Amount of Supersedeas Bond.

Plaintiffs were represented by counsel Joseph P. Cullan, Patrick J. Cullan and Joseph S. Fox. Defendants were represented by counsel Robert A. Mooney and Catherine L. Stegman. The State of Nebraska was represented by counsel Patrick G. Vipond.

Judgment was entered in this case on April 6, 2017. On April 17, 2017, Plaintiffs filed a Motion to Alter or Amend Judgment asserting, *inter alia*, an award of prejudgment interest. Defendants objected to the Court awarding prejudgment interest for reasons set forth on the record at the hearing on the subject motions. Noting the Defendants' objections, the Court finds that the April 6, 2017 judgment should be amended to include an award of prejudgment interest. Accordingly,

IT IS ORDERED:

- 1. Plaintiffs' Motion to Refrain from Ruling and to Expand Discovery is denied in its entirety.

2. Plaintiffs' Motion to Alter or Amend Judgment is granted, in part, and denied, in part, as follows:

a. The Verdict Order and Judgment entered April 6, 2017 is hereby amended to include an award of prejudgment interest covering the time period from September 9, 2013 up and until April 6, 2017, which is the date of judgment.

b. The applicable prejudgment interest rate is 2.641%, which is the rate in effect on the date of judgment.

c. The applicable postjudgment interest rate is 2.641%, which is rate in effect on the date of judgment.

d. Plaintiffs' Motion to Alter or Amend Judgment is denied in all other respects.

3. Ruling on Defendants' Motion to Set Amount of Supersedeas Bond is held in abeyance, the amount of said bond to be recalculated and resubmitted in accordance with this Order.
