in hand paid by Iowa State Highway Commission, do hereby sell and convey unto the STATE OF IOWA, for road purposes and for use as a Public Highway, the following described premises situated in the County of Polk, State of Iowa, to-wit:

Commencing at the SE¹ Cor. of Sec. 20, T. 75 N, R. 24 W of the 5th P.M., thence north 660.1 ft. along the west line of the SE¹ of said Sec. 20 to the point of beginning; Thence continuing north 660.0 ft., thence east 40.0 ft., thence south 660.0 ft., thence west 40.0 ft. to the point of beginning and containing 0.15 acres, more or less, exclusive of present established highway.

"Grantors hereby agree that no buildings, signs or other permanent improvements, or any trees, fences or hedges, more than 4 ft. in height shall be placed on a strip of land 10 ft. wide lying adjacent to and east of the east line of the above described right of way, said agreement to be binding on grantors, their heirs and assigns forever"

hereby relinquishes right of dower in and to the premises hereintore conveyed.


