DISCLAIMER AND RELEASE

KNOW ALL MEN BY THESE PRESENTS, that OMAHA PUBLIC POWER DISTRICT, a public corporation, for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby release and disclaim any rights it may have attained by virtue of the Plat and Dedication of Hillsborough Addition, as surveyed, platted and recorded in Douglas, Nebraska, over, upon, along and above the following described real estate:

A strip of land Ten feet (10') in width, being Five feet (5') each side of and abutting the common lot line of Lot 536 and Lot 537 of said Hillsborough Addition, and now known as Lot 1, Benz Addition.

A strip of land Ten feet (10') in width, being Five feet (5') each side of and abutting the common lot line of Lot 538 and Lot 539 of said Hillsborough Addition, and now known as Lot 2, Benz Addition and Lot 2, Hillsborough Replat 6 Addition.

A strip of land Sixteen feet (16') in width, being Eight feet (8') each side of and abutting the common lot line of Lot 537 and Lot 538, together with a strip of land Sixteen feet (16') in width, being Eight feet (8') each side of and abutting the common lot line of Lot 537 and Lot 539 of said Hillsborough Addition, and now known as Lot 2, Benz Addition.
