3. The Gas transmission lines described as follows:

Holdrege Branch Line:

(a) A 10 inch steel pipe gas transmission line approximately 31,841 feet in length and continuing as an 8 inch steel pipe line for approximately 99,485 feet, said 10 inch line beginning at a point on the east line of the SE $\frac{1}{4}$ of Sec. 12, T. 8 N., R. 9 W., and extending in a southwesterly direction across said Sec. 12 and Sections 11, 14, 15, 16, 17, 20 and 19 of said Township and Hastings to a point in the NE $\frac{1}{4}$ of Section 24, T. 8 N., R. 10 W., at which point the 10 inch line becomes 8 inches, continuing as an 8 inch pipe line in a southwesterly direction through Sections 24, 23, 22, 27, 28, 29, 30 and 31, in T. 8 N., R. 10 W.; thence through Sections 30, 35, and 34 of T. 8 N., R. 11 W.; thence through Sections 3, 4, 5, 6 and 7 of T. 7 N., R. 11 W.; thence through Sections 12, 11, 10, 15, 16, 17, 18 and 19 of T. 7 N., R. 12 W.

(b) Hastings Branch Line.

An 8 inch steel pipe gas transmission line, approximately 3.08 miles in length, extending from a point of connection with the Holdrege 8 inch line of Grantor in the SW $\frac{1}{4}$ of Sec. 24, T. 8 N., R. 10 W., southeasterly through said Sec. 24 and Sections 25 and 36, in said Township and Range; thence southerly through Sec. 31, T. 8 N., R. 9 W.; thence through Sec. 5 of T. 7 N., R. 9 W.; and thence to a point in the NE $\frac{1}{4}$ of Sec. 1, T. 7 N., R. 10 W.

(c) Hastings Industrial Line.
