## RIGHT OF WAY CONTRACT

FOR AND IN CONSIDERATION of the sum of ONE DOLLAR, to us in hand paid, receipt of which is hereby acknowledged, and the further consideration of Fifty cents per rod, to be paid when such grant shall be used or occupied Frederick Carter, Robert Carter and Elmer L. Frey, guardian, all unmarried, do hereby grant to NATURAL GAS DISTRIBUTING COMPANY, its successors or assigns, the right-of-way to lay, maintain, repair, operate, remove and relay a pipe line as located by grantee for the transportation of oil or gas, on, over and through certain lands situate in Adams County, State of Nebraska, described as follows:

The South east quarter of the south east and the west half of the south east quarter East of the C. B. & Q. Railroad Right of way, of Section fourteen (14) Township Seven (7), North Range Ten (10) West of the 6th P. M.

with ingress and egress to and from the same. Such pipeline is to be laid at such depth as not to interfere with cultivation of the soil. The said grantors, heirs or assigns, to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said grantees, which hereby agrees (in addition to above rodage payment) to pay any damages that may arise to crops and fences from the laying, maintaining and operating said line; said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one thereof to be appointed by the said grantors, heirs or assigns, one by the said grantee, successors or assigns, and the third by the two so appointed as aforesaid, and the award of three such persons shall be final and conclusive and no action shall be brought or maintained for damages until the amount thereof shall have been determined as above provided.
