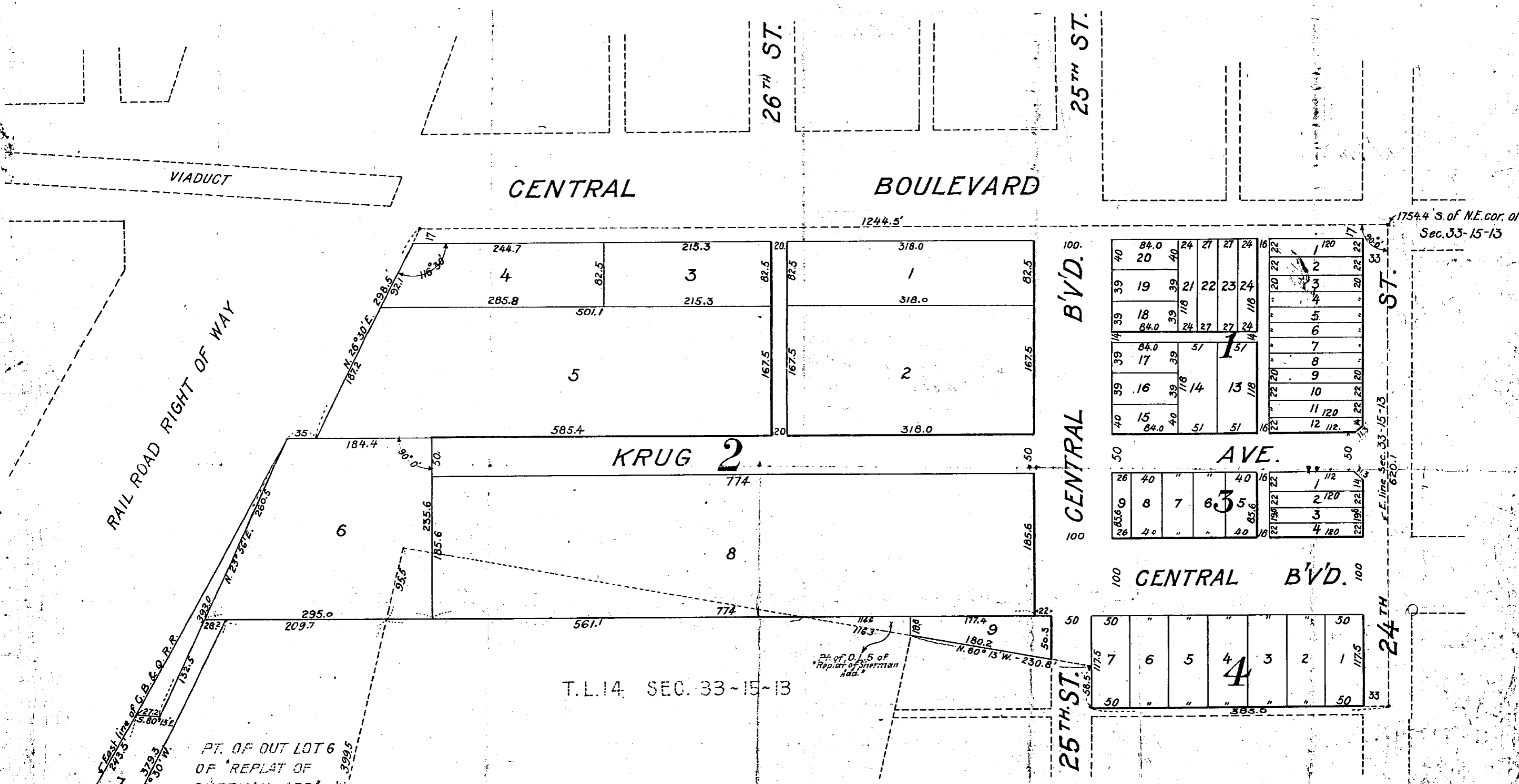


2ND. REPLAT OF SHERMAN ADD.



Omaha, Nebraska, Oct. 17th 1910.

Whereby certify that we have accurately surveyed and staked the lots, blocks, streets and alleys of the 2nd Replat of Sherman Add. and that the same is located as follows: Beginning at a point 1754.4 feet South of N.E. corner of section 33, township 18 North, Range 13 East of the 6th P.M., Douglas County, Nebraska; thence South on section line 620.1 feet; thence West 383.0 feet to the East line of 25th Street; thence North along the East line of 25th Street 58.5 feet; thence N. 80° 13' W. 230.8 feet; thence North 19.8 feet to the South line of Central Boulevard extended West; thence West 885.4 feet; thence S. 26° 30' W. 379.3 feet to the South line of Out Lot 6 of the Replat of Sherman Add.; thence N. 80° 13' W. 59.4 feet to the East Right-of-Way line of the C. & O. R.R.; thence N. 30° 33' E. along the East Right-of-Way line of the C. & O. R.R. 243.5 feet; thence S. 80° 13' E. 272 feet; thence N. 23° 56' E. 393.0 feet; thence East 35 feet; thence N. 26° 30' E. 298.5 feet to a point 17 feet North of the South line of Central Boulevard; thence East 1244.5 feet to place of beginning. Being the following Real Estate: (1) all of the Replat of Sherman Add. with the following exceptions: (a) that part of Out Lot 5 described as follows: Beginning at a point 225.7 feet South and 72.5 feet West of the N.E. corner of Out Lot 2 of Cleveland Place; thence North 19.8 feet; thence West 114.6 feet to place of beginning; (b) that part of Out Lot 6 described as follows: beginning at a point 225.7 feet South and 1286.1 feet West of the N.E. corner of section 33-15-13, said point being on the East line of U.L. 6 and being 95.5 feet on a course of S. 13° 06' W. from the N.W. corner of Tax Lot 14 and also being on the South line of Central Boulevard extended West; thence West 209.7 feet; thence South 26° 30' W. 379.3 feet to the South line of Out Lot 6; thence S. 80° 13' E. 293.0 feet to the S.E. corner of said Out Lot 6; thence N. 13° 06' E. 399.5 feet to place of beginning. (2) That part of T. L. 14, Sec. 33, Twp. 15 N., R. 13 E. lying North of the South line of Central Boulevard extended West; all as shown on the above Plat.

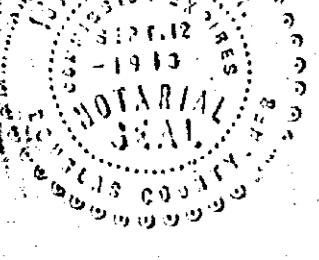
