## PARTIAL RELEASE AND DISCLAIMER

## WITNESSETH THAT:

WHEREAS, AMERICAN TELEPHONE AND TELEGRAPH COMPANY, a New York corporation, was granted certain right of way and easement rights upon, over and under certain land in Douglas County, Nebraska, by the Right of Way and Easement dated January 16, 1961, and recorded March 23, 1961, in Book 364 at Page 211 in the Register of Deeds office in Douglas County, Nebraska; and

WHEREAS, AMERICAN TELEPHONE AND TELEGRAPH COMPANY no longer requires all of the land covered by said Right of Way and Easement for the purposes set forth therein and desires to release from said Right of Way and Easement the property hereinafter described.
