KNOW ALL MEN BY THESE PRESENTS, That

Benson Feed Mills, Inc., a Nebraska Corporation

in consideration of One Dollar and other valuable consideration bargain, sell, convey and confirm unto

received from grantee, does grant

Larry B. Frost and Ethel M. Frost, Husband and Wife

as joint tenants with right of survivorship, and not as tenants in common, the following described real property in County, Nebraska:

Beginning at a point on the easterly line of Military Avenue on the south line of Lot 15, Block 10, Benson, 48 feet west of the Southeast corner of said Lot 15; thence northwesterly along the easterly line of Military Avenue 62.63 feet; thence east 126.3 feet to a point 4 feet east of the east line of Lot 16; thence south and parallel to the east line of said Lot 16, 57.45 feet to the north property line of Binney Street; thence west 102 feet to the place of beginning, being the south part of Lots 14, 15, 16 and the west 4 feet of Lot 17, as described above, all in Block 10, Benson, a Subdivision, and now a part of the City of Omaha, as surveyed, platted and recorded, Douglas County, Nebraska, together with easement granted in Book 1753, Page 338, Deed Records, Douglas County, Nebraska.

To have and to hold the above described premises together with all tenements, hereditaments and appurtenances thereto belonging unto the grantees and to their assigns, or to the heirs and assigns of the survivor of them forever.

And the grantor does hereby covenant with the grantees and with their assigns and with the heirs and assigns of the survivor of them that grantor is lawfully seized of said premises; that they are free from encumbrance except covenants, easements and restrictions of record; all regular taxes and special assessments, except those levied or assessed subsequent to date hereof; that grantor has good right and lawful authority to convey the same; and that grantor warrants and will defend the title to said premises against the lawful claims of all persons whomsoever.

It is the intention of all parties hereto that in the event of the death of either of the grantees, the entire fee simple title to the real estate shall vest in the surviving grantee.
