

COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT 1, ROANOKE BUSINESS PARK REPLAT ONE, SAID POINT ALSO BEING THE NORTHEAST CORNER OF LOT 22, ROANOKE BUSINESS PARK, A SUBDIVISION LOCATED IN SAID SECTION 05, SAID POINT ALSO BEING ON THE WEST RIGHT-OF-WAY LINE OF 118TH STREET; THENCE \$87°09'20"W (ASSUMED BEARING) ALONG THE SOUTH LINE OF SAID LOT 1, ROANOKE BUSINESS PARK REPLAT ONE, SAID LINE ALSO BEING THE NORTH LINE OF SAID LOT 22, ROANOKE BUSINESS PARK, A DISTANCE OF 255.14 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING S87°09'20"W ALONG SAID SOUTH LINE OF LOT 1 ROANOKE BUSINESS PARK REPLAT ONE, SAID LINE ALSO BEING SAID NORTH LINE OF LOT 22, ROANOKE BUSINESS PARK, A DISTANCE OF 25.00 FEET; THENCE N02*37'21"W, A DISTANCE OF 296.07 FEET; THENCE N21*46'30"E, A DISTANCE OF 50.30 FEET TO A POINT ON THE NORTHERLY LINE OF SAID LOT 1, ROANOKE BUSINESS PARK REPLAT ONE, SAID LINE ALSO BEING THE SOUTHERLY RIGHT-OF-WAY LINE OF ROANOKE BOULEVARD; THENCE SOUTHEASTERLY ALONG SAID NORTHERLY LINE OF LOT 1, ROANOKE BUSINESS PARK REPLAT ONE, SAID LINE ALSO BEING SAID SOUTHERLY RIGHT-OF-WAY LINE OF ROANOKE BOULEVARD ALONG A CURVE TO THE LEFT WITH A RADIUS OF 339.01 FEET, A DISTANCE OF 25.64 FEET, SAID CURVE HAVING A LONG CHORD WHICH BEARS S55*28'14"E, A DISTANCE OF 25.63 FEET; THENCE S21*46'30"W, A DISTANCE OF 39.23 FEET; THENCE S02*37'21"E, A DISTANCE OF 290.57 FEET TO THE POINT OF BEGINNING.
