EXHIBIT "A"

The land referred to is situated in the State of Nebraska, County of Douglas and is described as follows:

A tract of land in the Southeast Quarter of the Northwest Quarter (SE¼ NW¼) of Section 4, Township 14 North, Range 12 East of the 6th P.M., in the City of Omaha, in Douglas County, Nebraska, the boundaries of which are more particularly described as follows:

Commencing at the center of said Section 4, which point is also the point of intersection of the centerlines of "L" Street and 102nd Street; thence North 00°38'50" West, along the East line of the Northwest Quarter of said Section 4, which line is also the centerline of 102nd Street, 1,278.98 feet; thence South S89°53'00" West, 30.00 feet, to the point of beginning; which is also the point of intersection of the West right of way line of 102nd Street and the South right of way line of "I" Street; thence South 00°38'50" East, along the West right of way line of 102nd Street, 308.30 feet to a point on the Northerly right of way line of the Union Pacific Railroad; thence Northwesterly, 296.35 feet, along the Northerly right of way of the Union Pacific Railroad, which is the arc of a circular curve whose radius is 349.27 feet, and whose chord length and bearing are 287.54 feet and North 52°53'50" West, respectively; thence North 28°42'05" West, continuing along the said railroad right of way line, 12.79 feet, on a line tangent to the last described curve; thence continuing along said railroad right of way line, 131.78 feet, along the arc of a circular curve which is tangent to the last described line and whose radius is 449.28 feet, and whose chord length and bearing are 131.31 feet and North 20°28'05" West, respectively, to a point on the South right of way line of "I" Street; thence North 89°53'00" East, along the South right of way of "I" Street, 277.95 feet, to the point of beginning.
