ORDINANCE NO. 8816

AN ORDINANCE vacating parts of 19th Street, Harney Street and the Alley adjoining East 1/2 of Block $251\frac{1}{2}$, in the City of Omaha.

WHEREAS, the owners of all the real estate abutting upon the West Side of 19th Street and the South Side of Harney Street, and the East Side of Alley in Block 251½, City of Omaha, being Lots 1, 2, 3 and Strip on East in said Block 251½, have petitioned the Mayor and City Council to vacate the following parts of 19th Street, Harney Street and the Alley in said Block as follows: South 0.68 of Harney Street from 19th Street to Point 0.81 feet West of East line of Alley between 19th Street and 20th Street, also West 0.44 feet of 19th Street from South line of Block 251½, City of Omaha, to Point 140 feet North thereof, also East 0.81 feet of Alley in said Block 251½, City of Omaha, and

WHEREAS, said vacation is requested on account of a shortage in the lots as surveyed, platted and recorded and to allow the construction of the building as planed and contracted for, it is deemed advisable that said vacation be made.

THEREFORE,
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That that part of 19th Street described as follows: "Beginning at a Point 20 feet East of the South East Corner of Lot 3, Block 2512, City of Omaha; thence East 0.44 feet; thence North

parallel with the West Line of 19th Street to a Point 0.68 feet North and 20.44 feet East of North East Corner of Lot 1, Block 251½, City of Omaha; thence West 0.44 feet; thence South to place of beginning, That part of Harney Street described as follows, "Beginning at a Point 2C feet East of the North East Corner of Lot 1, Block 251½, City of Omaha; thence North 0.68 feet; thence West parallel with the South Line of Harne Street to a Point 0.68 feet North and 0.81 feet West of the North West Corner of Lot 1, Block 251½, City of Omaha; thence South 0.68 feet; thence East to place of beginning, also the East 0.81 feet of the Alley in Block 251½, City of Omaha; and the East 0.81 feet of the Alley

Section 2. That this ordinance shall take effect fifteen days after its passage and be in force thereafter.
