HOMER J. SOUTHWICK, ET AL. A SEASEMENT FOR ELECTRIC LINES

TO CONSUMER'S PUBLIC POWER DISTRICT SOUTHWICK AND ALL MEN BY THESE PRESENTS:

That Philip O. Southwick and Dorothy H. Southwick his wife,

Homer J. Southwick and Gladys H. Southwick his wife of Saline County, Nebraska, in consideration (If grantor is not married add words "an unmarried person")

of \$1.00, receipt of which is hereby acknowledged, and the further payment of a sum to make a total payment of \$11.00 for 9 poles and 2 anchors when set on the following described property,

do___ hereby grant and convey unto the Consumers Public Power District (hereinafter called

"District") its lessess, successors and assigns, the permanent right, privilege and easement of a right-of-way to construct, operate, maintain and remove all necessary poles, wires, guys and other necessary equipment in connection therewith, on and across the following described property situated in Saline County, Nebraska, more particularly described as follows:

The Southwest Quarter (SW\factor) of Section Thirteen (13) Township Eight (8) North, Range One (1)

East of the 6th P.M. Saline County, Nebraska. Except the right-of-way of the C.B. & Q. Railroad Company as at present located on and across said land.

The pole line herein contemplated shall be located on the property approximately as follows: Poles to be set Thirty-four (34') feet East of the section line on the West side of the above described property. Two anchors to be set approximately One (1) foot North of the South property line and 73' and 78' respectively, East of the West Section line of the above described property. All poles and anchors to be located North of said C.B.& Q. R.R. right-of-way. Above mentioned South property line is that line established on the North side of C. B. & Q. Railroad right-of-way and that part of the SW1 of Section 13, Township eight (8), North, Range One (1) East of the 6th P.M. Saline County, Nebraska, laying north of said C. B. & Q. Railroad Company right-of-way.

The District shall also have the privilege and easement of ingress and egress across the property to its officers and employees for any purpose necessary in connection with the construction, operation, maintenance, inspection and removal of said line.

The District shall also have the right at any time to trim or remove such trees and underbrush as may in any way endanger or interfere with the safe operation of the lines and equipment used in connection therewith.

The District shall at all times excerise all due care and diligence to avoid injury or damage to the crops, livestock and other personal property of the Grantor, and the District shall indemnify and save harmless the Grantor from any such damage and loss arising or occurring to such property solely by reason of the construction, operation, maintenance and removal of said transmission lines.

The District agrees that should the transmission lines constructed hereunder be abandoned for a period of five years, the right-of-way or easement hereby secured shall then cease and terminate, and this contract shall be of no further force and effect.
