Book 2, Page 167 and Amendments 1 through 16, listed on the attached Exhibit B. Upon said review of this Dedication and Amendments 1 through 16, and of my own personal knowledge of the property, I have determined: i) Only the property designated Tract 2 on the attached sketch, was included in the metes and bounds as property on which 42 townhouse units were located in the description of the property attached to the 1989 Dedication. ii) That neither Tract 1 as a whole or part thereof, was referenced or included in the description of property set out in the Dedication or any of the 16 Amendments. iii) That the real estate metes and bounds descriptions recited in the 16 amendments and the location of the additional units added to the time-share Declaration by said 16 amendments are properties and locations lying outside of Tract 2. There are no townhouse units built on either Tract 1 or Tract 2.


