MEMORANDUM OF TENANTS IN COMMON BUY-SELL AGREEMENT

This MEMORANDUM OF TENANTS IN COMMON BUY-SELL AGREEMENT is made and executed by and between FRANCIS V. BISKUP ("Biskup") and AVM REAL ESTATE INVESTMENTS, LLC, a Nebraska limited liability company ("AVM").

RECITALS:

WHEREAS, Biskup and AVM own, as tenants in common, the real property described on Exhibit "A" attached hereto ("Property"); and

WHEREAS, Biskup and AVM have entered into that certain Tenants in Common Buy-Sell Agreement dated as of February 17, 2011 ("Agreement") pursuant to which each of the parties has granted to the other certain rights and options to purchase from the other all of a party's ownership interest in the Property, according to the terms and provisions set forth therein, including a put/call option, right of first refusal and rights upon death of Biskup or Thomas J. This Memorandum is executed and delivered with the understanding and agreement that the same shall not in any manner or form whatsoever, alter, modify or vary the purchase price or the other terms, covenants and conditions of the Agreement, or the specific circumstances under which one party has the option or obligation to purchase or sell his or its interest in the Property under any of the Options.

Legal Description of Property

Parcel A:
