

ORDINANCE NO. 2197-91

AN ORDINANCE CREATING PAVING DISTRICT NO. 191 IN THE CITY OF NEBRASKA CITY, NEBRASKA, ORDERING THE CONSTRUCTION OF STREET IMPROVEMENTS THEREIN AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF NEBRASKA CITY, NEBRASKA, as follows:

Section 1. That there be and hereby is created in the City of Nebraska City, Nebraska, a paving district to be known and designated as Paving District No. 191 of the City of Nebraska City, Nebraska.

Section 2. That the limits, boundaries and improvements to be made in Paving District No. 191 of said City are defined and established as follows:

Beginning at the Northwest corner of Block 72, South Nebraska City Addition to Nebraska City, Otoe County, Nebraska, thence East to the Northeast corner of said Block 72, thence Northeasterly to the Southwest corner of Block 60, Kearney Addition, thence Southeasterly to the South corner of Block 59, Kearney Addition, thence Southwesterly to the Southeast corner of Lot 1, Block 63, Kearney Addition, thence Southerly to the Northeast corner of Lot 3, Block 67, Kearney Addition, thence Southerly to the Northeast corner of Lot 14, Block 67, Kearney Addition, thence Westerly to the Northwest corner of Lot 10, Block 68, Kearney Addition, thence Northerly to the Northwest corner of Lot 9, Block 68, Kearney Addition, thence Northwesterly to the Southwest corner of Block 73, South Nebraska City Addition, thence Northerly to the Point of Beginning, including Blocks 72 and 73, South Nebraska City Addition, Blocks 62 and 63, Kearney Addition and Lots 3 through 8, Block 67, Kearney Addition and Lots 1 through 9, Block 68, Kearney Addition.

and within which District the following streets shall be improved by paving with integral curb, gutter, storm sewer and such other appurtenances as are necessary thereto:

3rd Rue from 8th Terrace to 10th Corso;
10th Corso from 3rd Rue to 2nd Street; and
2nd Street from 10th Corso South One-half Block.

Section 3. Said streets shall be improved at public cost and said improvements shall be made in accordance with the plans, specifications and estimate prepared by the special engineer employed by the City and to be approved by the Mayor and Board.


