

GRANT OF EASEMENT

KNOW ALL MEN BY THESE PRESENTS, THAT The Salvation Army  
A Corporation  
hereinafter referred to as grantor (s), for valuable consideration, do  
(does) grant unto County of Sarpy  
hereinafter referred to as grantee (s), an easement over, across and  
upon the following described real estate to-wit: Tax lots C and D2 and  
Government lots 4 and 5 in the S½ of Section 26, T13N, R13E Sarpy  
County Nebraska

for the purpose of constructing and maintaining An agricultural levee  
and obtaining Borrow Material therefor as described in Plan Numbers  
M (R-613) C1-310E of the U.S. Army Corps of Engineers. Grantee agrees to  
provide a road way on the long berm area approximately in the same  
position as the present road. Grantee further agrees to raise or other  
wise adjust any buildings or utilities affected by the proposed levee  
or its related protective devices. Grantee further agrees to provide  
access ramps on both land side and river side, of the proposed levee.

Grantee (s) shall have the right to ingress and egress over, upon  
and across said real estate for the purpose of constructing, maintaining  
or removing said works. This easement shall be binding on the grantor(s)  
or their successors, heirs and assigns for an indefinite period of time,  
but shall lapse and have no force or effect whenever the works or const-  
ruction are not used for the purpose or purposes originally intended by  
the parties.
