That the application of Tabitha, Inc., hereinafter referred to as "Permittee", to amend the development and occupancy schedule for the paving of certain parking lots be and the same is hereby granted under the provisions of Sections 27.63.030 and 27.63.080 of the Lincoln Municipal Code, and the revised development and occupany schedule attached hereto and marked as Exhibit "A" to extend the completion dates for the paving of the parking lots authorized under Special Permit No. 384B is hereby approved. All other terms, conditions, and requirements of Special Permit No. 384B shall remain in full force and effect.

The terms, conditions, and requirements of this resolution shall be binding and obligatory upon the Permittee, successors, and assigns. The building official shall report violations to the City Council which may revoke the special permit or take such other action as may be necessary to gain compliance.

The Permittee shall sign and return the City's letter of acceptance to the City Clerk within 30 days following approval of the special permit, provided, however, said 30-day period may be extended up to six months by administrative amendment. The City Clerk shall file a copy of the resolution

approving the special permit and the letter of acceptance with the Register of Deeds, filing fees therefor to be paid in advance by the Permittee.
