MEMORANDUM OF THE OPTION AND SITE LEASE AGREEMENT

- 1. <u>Lease</u>. Landlord leases to Tenant and Tenant leases from Landlord the Site, together with the right of ingress and egress thereto, pursuant to the terms and conditions of the Lease.
 - 2. Term. The initial term of the Lease is five (5) years and commenced on September 1, 2000.
- 3. Other Provisions. The terms of this Memorandum are not intended to vary with the terms and conditions of the Lease. This Memorandum is subject to all of the terms and conditions of the Lease, and any amendments, renewals, or extensions of the Lease. In the event of any conflict between the provisions of this Memorandum and the provisions of the Lease, the Lease shall control.
