| 13                                 | WHEREAS, the Lincoln City-Lancaster County Planning Commission has   |  |  |

WHEREAS, said site plan together with the terms and conditions hereinafter set forth are consistent with the comprehensive plan of the City of Lincoln and with the intent and purpose of Title 27 of the Lincoln Municipal Code to promote the public health, safety, and general welfare.

NOW, THEREFORE, BE IT RESOLVED by the Lincoln City-Lancaster County Planning Commission of Lincoln, Nebraska:

That the application of Tabitha, Inc., hereinafter referred to as "Permittee", to add a new 12 bed hospice care facility and an expansion of the campus to include two 12 bed assisted living units, be and the same is hereby granted under the provisions of Section 27.63.080 of the Lincoln Municipal Code upon condition that operation of said hospice care facility and assisted living units be in substantial compliance with said application, the site plan, and the following additional express terms, conditions, and requirements:

- This approval permits a new 12 bed hospice care facility and an expansion of the campus to include two 12 bed assisted living units.
  - 2. Before receiving building permits, the Permittee shall:
    - a. Cause to be prepared and submitted to the Planning
      Department a revised and reproducible final plot plan including
      5 copies showing the following revisions:
      - i. Show the north setback for the existing north parking lot.
      - ii. Show a 10' setback from the rear lot line to the new parking lot between the dwellings in the Northwest Area and to include a 6' solid fence and provide 80% evergreen landscaping from 6' to 12' high in the 10' setback west of the parking, as shown on the site plan.

iii. Increase the side yard setback along the north lot line 1 2 for the northmost assisted living dwelling to 20'. 3 Revise Note #1 to include the statement: A 10' tall, ĺν. 4 100% landscape screen shall be provided along the 5 north lot line of the northmost assisted living dwelling 6 located west of South 47th Street and north of J Street. 7 Revise the term "green house" to another which does ٧. 8 not conflict with the Zoning Ordinance. 9 vi. Show the sanitary sewer and manhole to the 10 satisfaction of Public Works. 11 b. The construction plans substantially comply with the approved 12 plans. 3. 13 Before occupying buildings, all development and construction shall 14 substantially comply with the approved plans. 15 4. All privately-owned improvements, including landscaping and 16 screening, are to be permanently maintained by the Permittee. 17 5. The physical location of all setbacks and yards, buildings, parking 18 and circulation elements, and similar matters must be in substantial compliance with the 19 location of said items as shown on the approved site plan. 20 6. The terms, conditions, and requirements of this resolution shall run 21 with the land and be binding upon the Permittee, its successors and assigns. 22 7. The Permittee shall sign and return the letter of acceptance to the City 23 Clerk within 60 days following the approval of the special permit, provided, however, said 60-day period may be extended up to six months by administrative amendment. The City 24 25 Clerk shall file a copy of the resolution approving the special permit and the letter of
