The Matter of adding all the territory of School District number 105 to School District number 1, of Lancaster County aforesaid, came on to be heard upon the petitions of the respective districts filed August 14, 1886, and of record in the County Superintendent's office.
In the Matter of transferring School District No. 105 to School District No. 1 of said County.

After reading the petitions, affidavits of notice, and the list of legal voters, and being satisfied that due and legal notice had been given, and that no objections had been filed, I find that the prayer of said petitions should be granted.

It is therefore Ordered, That all of the territory of School District number 105 of said County, be and the same is hereby added to said School District number 1, and made a part thereof which said territory so added is described as follows: The S. 1/4 of Sec. 17, S. E. 1/4 of Sec. 18, all of Sec. 19, S. 2 of Sec. 20, N. 2 of Sec. 29, S. 1/4 Sec. 29, all of Sec. 30, all in Town 10, Range 7, Lancaster County, Nebraska.

It is hereby further ordered that all school property of said district number 105, and all taxes due or collected by said district, or to the credit of said district over and above the liabilities of said school district number 105, be and the same are hereby the property of said school district number One.
