MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is made by and between CYNET, INC., a Nebraska Corporation ("Landlord") and AUTO PROS MILLARD, INC., a Nebraska Corporation ("Tenant").

WITNESSETH;

Landlord and Tenant have heretofore entered into a Lease executed the 18th day of October, 1991, with respect to certain premises commonly known as 4870 South 137 Street, Omaha, Nebraska and more particularly described on Exhibit "A" attached hereto and by this reference incorporated herein and located within Moritz Plaza, and Addition to the City of Omaha, Douglas County, Nebraska.

Said Lease runs for a term of fifteen (15) years commencing on the first day of June, 1992.

Said Lease provides that the Tenant pay rent during the Lease Term in accordance with said lease. Said Lease provides that the Tenant shall have a right of first refusal to purchase said premises during the Lease Term, which right of first refusal is subordinate to the terms, conditions and provision of Landlord's financing and which right of first refusal is subject to the provisions of Article 30 of said Lease.

This Memorandum of Lease does not amend or modify the referenced Lease but this Memorandum is executed in order that it

might be recorded to give notice of the respective rights of the Tenant and the Landlord.
