QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, that the NORRIS PUBLIC POWER DISTRICT, a public corporation organized under the laws of the State of Nebraska, with its principal offices and place of business in the City of Beatrice, State of Nebraska, in consideration of One Dollar in hand paid and other and further valuable considerations as set forth in Contract No. DA-25-066-CIVENG-64-45, dated 2 March 1964, with the UNITED STATES OF AMERICA, receipt of which is hereby acknowledged, and in pursuance of said contract, the NORRIS PUBLIC POWER DISTRICT does hereby quitclaim and convey unto the UNITED STATES OF AMERICA and its assigns forever, all of its right, title, and interest, in and to the following described real property, situate, lying and being in Township 10 North, Range 5 East of the Sixth Principal Meridian, Lancaster County, Nebraska, to-wit:
