QUITCLAIM DEED TO MINERALS

The UNITED STATES OF AMERICA, hereinafter called the Government, in order to carry out the return of trust assets requirements of Public Law 499, 81st Congress (64 Stat. 98), does hereby REMISE, RELEASE AND FOREVER QUITCLAIM unto the State of Nebraska, acting by and through the Director of Agriculture and Inspection, and unto its successors and assigns, all of the right, title and interest which the Government reserved in and to the oil, gas, coal and other minerals in its deeds to grantees, executed on dates, recorded on dates and in books and at pages in Douglas County, State of Nebraska, as follows:

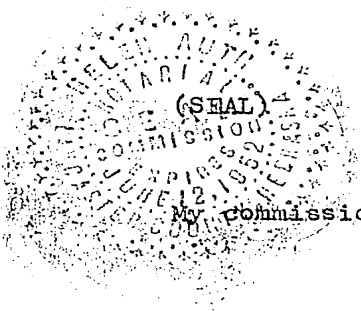
