## EXHIBIT "A"

Part of the SE 1/4 SE1/4 of Section 12, Township 15 North, Range 10 East of the 6th Principal Meridian, Douglas County, Nebraska, and more particularly described as follows: From the southeast corner of Section 12, Township 15 North, Range 10 East; thence N 90°00′00" W (assumed bearing) along the south line of the SE 1/4 of said Section 12 a distance of 582.36 feet; thence N00°00′48" W a distance of 236.87 feet to a pin found, said point being the true Point of Beginning; thence continuing N00°00′48"W a distance of 199.80 feet to a pin found on the south line of Chappell Addition to the City of Elkhorn, Nebraska; thence S89°46′44"E along said line a distance of 491.94 feet to a pin found on the westerly right-of-way line of State Highway No. 31; thence S09°15′28"W along said westerly highway right-of-way line a distance of 202.47 feet to a pin found; thence N89°45′32"W a distance of 459.32 feet to the point of beginning, and containing 2.18 acres, more or less.
