AGREEMENT

THIS AGREEMENT, made and entered into this **2**/day of March, 2002, by and between Dowd Grain Company, Inc., a Nebraska Corporation, ("Dowd") and the State of Nebraska, Department of Roads, ("State").

WHEREAS State seeks to acquire from Dowd a stockpile site of approximately 12.70 acres. as described on attached Exhibit "A", and right-of-way for road purposes of approximately 7.74 acres, as described on attached Exhibits "B" and "C", along Interstate 80 in the vicinity of State Highway 370 in Sarpy County, Nebraska in connection with State Project No 80-9(808), and

WHEREAS Dowd seeks to acquire approximately 5.84 acres of right-of-way presently owned by State, as described on attached Exhibit "D", and

WHEREAS the parties have reached agreement concerning the terms and manner of the acquisitions described above.

NOW THEREFORE in consideration of the following covenants and conditions the parties agree as follows:

- 1. At closing State shall convey by Quitclaim Deed to Dowd the land described on Exhibit "D".
- 2. In exchange for the conveyance of 5.84 acres from State, Dowd shall convey 5.84 acres of the right-of-way described on Exhibits "B" and "C" to State. Dowd shall convey the remaining 1.90 acres of right-of-way described on Exhibits "B" and "C" to State in exchange for the sum of \$60,800.00. At closing Dowd shall execute any other documents or instruments necessary to complete the conveyance to State and State shall pay the consideration due to Dowd.
- 3. Dowd shall lease the lands described on Exhibits "A" and "D" to State in accordance with the terms and conditions of the Lease Agreement attached hereto as Exhibit "D". The Lease Agreement shall be signed at closing.
- 4. In the event that after Dowd has completed the grading of its property adjacent to the land described on Exhibits "B" and "C", the area of land necessary for the construction of State project I-80-9(808) will lessen, making a portion of the lands acquired from Dowd "excess land". For a period of one year after the completion and acceptance of Project I-80-9(808), Dowd shall have the right to purchase any land determined by the State to be "excess land" from the sum of \$32,000.00 per acre.
