ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS: That this ASSIGNMENT is made and entered into this 7th day of August, 2008, by Sanitary and Improvement District No. 224 of Sarpy County, Nebraska, hereinafter ASSIGNOR.

That for one dollar and other good and valuable consideration, the sufficiency and adequacy of which is hereby acknowledged, GRANTOR, by and through the undersigned does hereby assign to COUNTY OF SARPY, OF THE STATE OF NEBRASKA, a body politic and corporate, also created and existing under and by virtue of the laws of the State of Nebraska, ASSIGNEE herein, all of ASSIGNOR's right, title, and interest, in and to a certain sanitary sewer system, including any and all easements, equipment, and other property owned or used by ASSIGNOR, and any rights and obligations therein including those granted by virtue of a certain Permit(s) to Perform Work on Public Right-of-Way issued by the State of Nebraska, Department of Roads, Permit No. 0-32340 and 0-32341, as located within the following described property, to wit:

Permit No. 32341:

Along the South Side of Nebraska State Highway 370 beginning at a point 500 feet East of the West Line of Section 35, Township 14 North, Range 11 East of the 6th P.M. in Sarpy County Nebraska, 1575 feet east of Milepost no. 4 and extending 2080 feet East; and,

Permit No. 32340:

Underneath of Interstate 80 at a point 127 feet north of the North line of Section 35, Township 14 North, Range 11 East of the 6th P.M. in Sarpy County, Nebraska, said point being 1375 feet East of the Milepost No. 439;

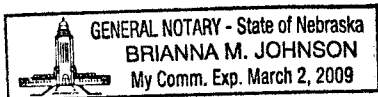
