This Agreement, made and entered into this 5 day of NOVEMBER,
1962, by and between Bernice M. Harder
of the County of SARPY, State of NEBRASKA,
Address GRETNA NEBRASKA

hereinafter called the OWNER, whether one or more, and the State of Nebraska,
Department of Roads, hereinafter called the STATE.

WITNESSETH: In consideration of \$ 25.00, the OWNER agrees to
convey to the STATE a permanent easement in and to a tract of land described
as follows:

That part of the West Half of the North-
west Quarter in Section 35, Township 14 North, Range
11 East of the 6th P.M., Sarpy County, Nebraska,
lying within 660 feet of Interstate Highway right
of way-controlled access line as measured at right
angles to Interstate Highway centerline.

The STATE agrees to pay the above consideration to the OWNER upon
execution of the permanent easement by the OWNER.

It is understood that said easement shall be used by the STATE for the
control of outside advertising signs, displays, and other advertising devices
in accordance with the rules and regulations of the STATE relating to the
control of advertising in areas adjacent to the National System of Interstate
and Defense Highway in Nebraska, which were duly adopted pursuant to law and
in accordance with the provisions of Section 84-907, R.R.S., 1943; approved
and filed on June 15, 1961, a copy of which is attached hereto and made a
part of this Agreement.

Upon acceptance and execution of this Agreement by the STATE, the STATE
shall have the right to immediately control advertising pursuant to the rules
and regulations referred to above.

It is understood that the rules and regulations shall speak for themselves
and no verbal statements, or interpretations, concerning such rules and
regulations, or other promises, agreements, or understanding, except as set
forth in this Agreement, will be honored by the STATE.

The OWNER hereby states that they have read or have had an opportunity
to read the rules and regulations referred to above.


