Quarter of said Section 34; thence northerly on the East line of the  
North Half of the Southwest Quarter of said Section 34 a distance of  
607.24 feet; thence southwesterly on a 5,579.6 foot radius curve to  
the right (initial tangent of which forms an angle of 138 degrees 34.2  
minutes left with said East line) a distance of 871.33 feet, more or
