**BACKGROUND:**



As of the date CenturyLink signs this Release, CenturyLink vacates and releases all of its right, title and interest in and to any and all easements and easement rights acquired by CenturyLink pursuant to the Utility Easement as per the above referenced subdivision plat as affecting the common side Lot lines of Lot 11 and Lot 12 and the utility easement affecting Lot 11 and Lot 12 Owen Parkway.

All of CenturyLink’s right, title and interest in and to any and all easements and easement rights acquired by CenturyLink pursuant to the Utility Easement with respect to all other real property outside of the Released Easement Tract remain and are not affected by this Release.



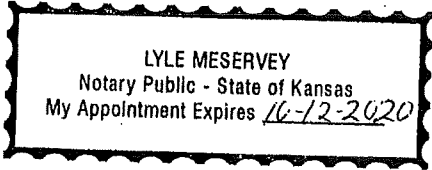
