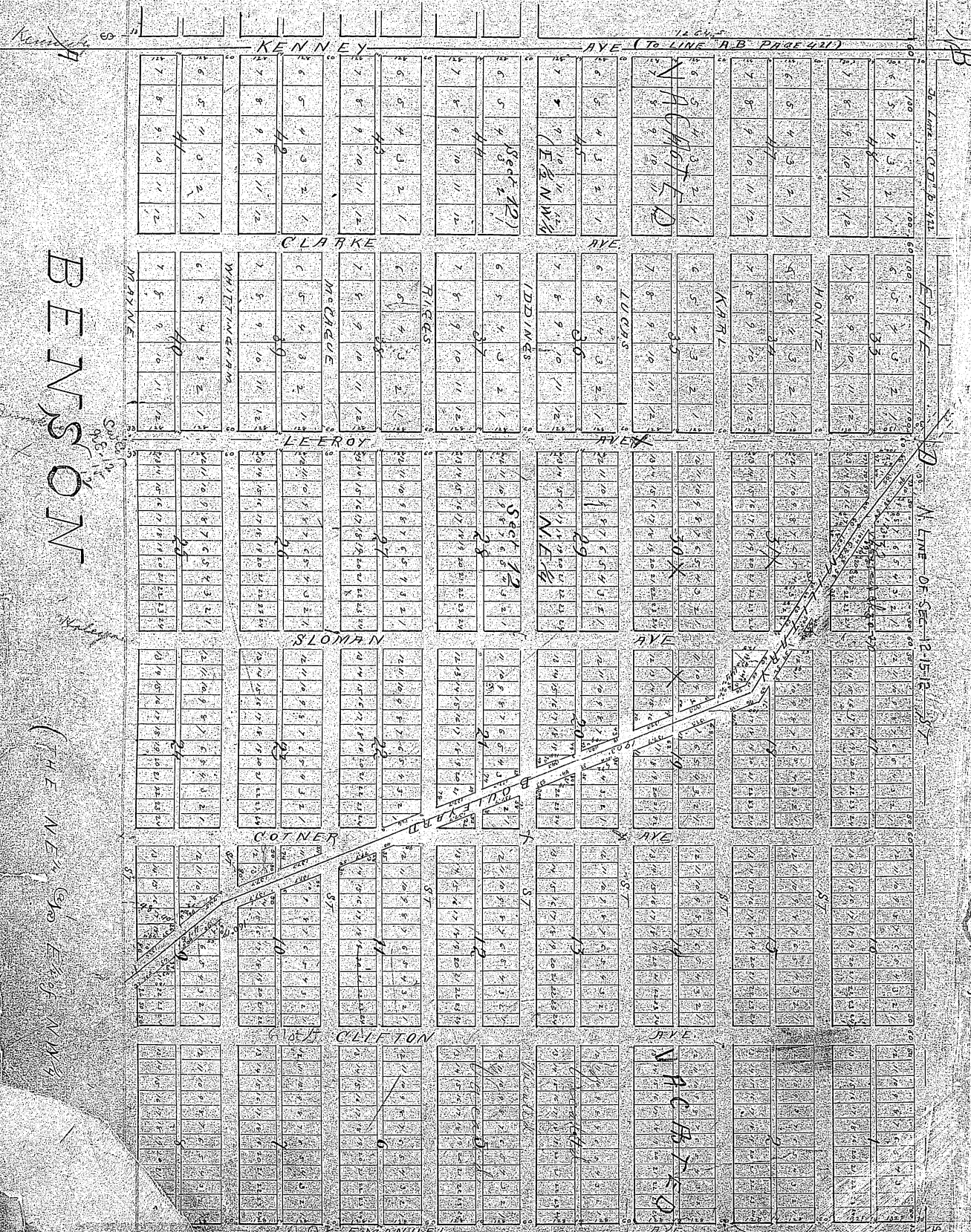


MAP OF

(THE NEW 90' EAS. OF N.W.S.)

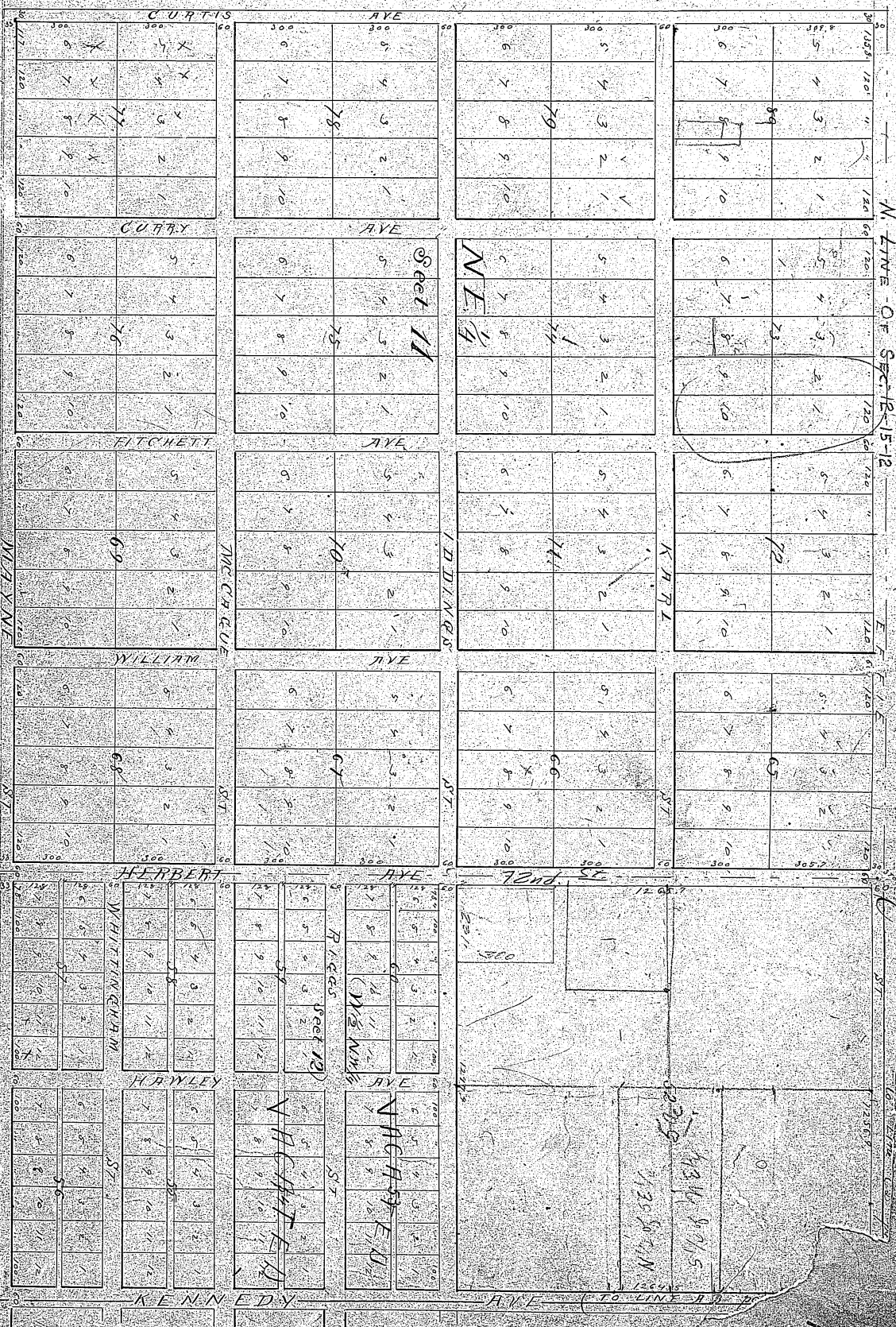

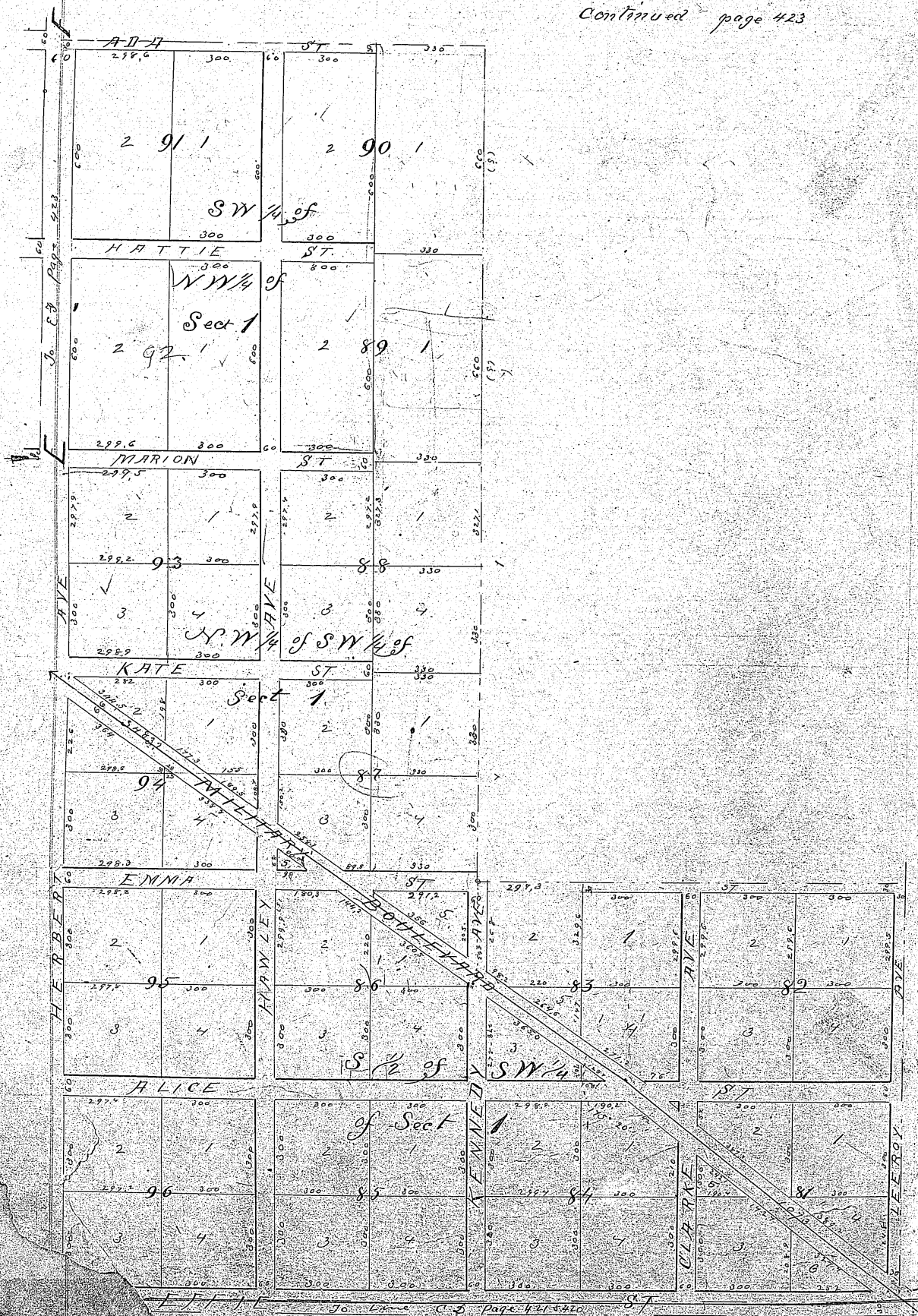

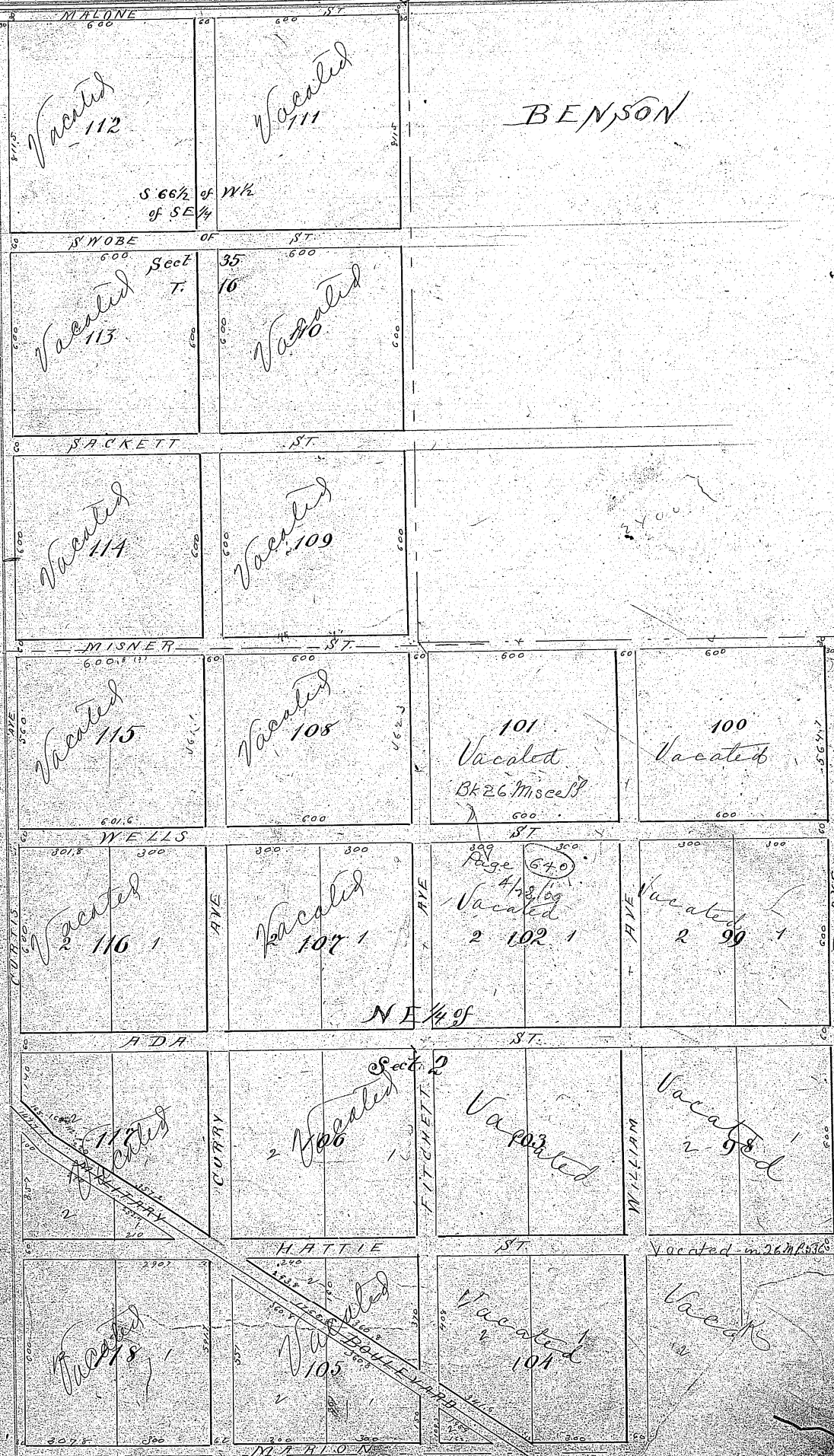
