At a regular meeting of the Chairman and Board of Trustees of the Village of Milligan, Nebraska, held in said Village on the 4th day of March, 1913, the following among other things were had and done there being present, Chairman, Rrank Rischling\$ and trustees, C. Smrha, Jr., J. V. Kotas, and Albert Placek, to-wit:

The following petition filed in the office of the Village Clerk on the 4th day of March

1913, was read -

₩e, the undersigned property owners and inhabitants of territory adjacent to the Village of Milligan, Nebr., being divided into Blocks numbered from 17 to 20 inclusive and sub-divided into Lots numbered from 95 to 130 inclusive, conforming as nearly as may be to the Blocks, Lots and Streets of said Village pray that the said adjacent territory may be annexed to the said Village of Hilligan, Nebraska, and be made a part of the incorporated limits thereof:

Upon motion being made and seconded that the prayer of the petition be granted and upon roll being called the following members voted Yea:- C. Smrha, Jr., Albert Placek, J. V.

Kotas and Frank Rischling, The Chairman declared the motion carried.

There was presented and came on for consideration of the Chairman and Board of Turst

ees, ordinance No. 36 as follows:-

An ordinance declaring certain described territory adjacent to the Village of Milligan Nebraska, annexed thereto and extending the corporate limits of said Village to include said territory.

Be it ordained by the Chairman and Board of Trustees of the Village of Milligan, Neb-

raska,

1. That the following described territory, to-wit: Commencing at a stake 20 feet east of the North East corner of Lot 22, Block 4, First Addition to Milligan, Nebraska, extending 570 feet north to a stake being 20 feet east of the North East corner of Lot 13, Block 3, First Addition to Milligan, Nebraska\$ thence 720 east to a stake; thence 570 feet south to a stake; thence 720 feet west to the point of beginning, is hereby annexed to the original cornerate limits of the Milligan Nebraska, and the said nexed to the original corporate limits of the Village of Milligan, Nebraska, and the sail corporate limits of said Village are hereby & & extended to include all of the above described territory.

2. The territory annexed herein shall be known as the Placek's Third Addition

to Milligan, Nebr.

3. This ordinance shall take effect and be in force from and after its adoption

Ordinance No. 36 was read for the third and final time, and it was moved and seconded that the ordinance be passed.
