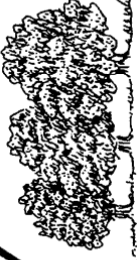

121 ORDINANCES OF THE CITY OF NEBRASKA CITY.

ord "B" at page 484 of the records of Otoe county, Nebraska, be and the same is hereby declared to be annexed to the city of Nebraska City.

SEC. 2. That the corporate limits of the city of Nebraska City are hereby extended to include the above territory.

SEC. 3. That this ordinance be in force and take effect from and after its passage, approval and publication.
Approved February 8, 1884.

ORDINANCE NO. 66.

An Ordinance granting Nebraska Railway Company privilege to construct tracks on Third Street and Fourth Corso.

Be it ordained by the Mayor and Council of the city of Nebraska City,

SEC. 1. That the Nebraska Railway Company are granted the right and privilege to construct, lay and build a railroad track and switch tracks on and across Third street and Fourth Corso, commencing near the south-west corner of block No. 23, running thence north across Fourth Corso to the alley in block No. 2 in South Nebraska City, and to use and occupy so much of said premises as may be necessary for the construction and use of such track and switches.

SEC. 2. This ordinance shall take effect and be in force from and after its passage and approval.
Re-approved July 23, 1888.

ORDINANCE NO 67.

An Ordinance providing for the vacating of the Alley in Block number One in Nebraska City proper.

Be it ordained by the Mayor and Council of the city of Nebraska City,

SEC. 1. That the alley in block number one in Nebraska City proper be and the same is hereby vacated.

SEC. 2. This ordinance shall take effect and be in force from and after its passage, approval and publication.
Re-approved July 23, 1888.

ORDINANCE NO. 68.

An Ordinance providing for the vacating of the Alley in Block number Sixty-five South Nebraska City.

Be it ordained by the Mayor and Council of the city of Nebraska City,

SEC. 1. That the alley in block number sixty-five in South Nebraska City now a part of Nebraska City be and the same is hereby vacated.

SEC. 2. This ordinance shall take effect and be in force from and after its passage, approval and publication.
