Know All Men by These Presents: THAT Grace B. Mullace, Vera M. Nielsen and S. R. Nielsen, her husband and Blanche Clements and John Clements, her husband of the County of and State of Modraska for and in consideration of the sum of Fifty Cents (Soc) per lineal real, receipt of One Dollar (\$1.00) of which consideration is hereby acknowledged and balance of which is to be paid when and as the location of pix lines ager and through the lands hereinafter described shall be established, surveyed, and measured, and the further consideration of the perfermance of the companis and agreements by the grantee, as hereinafter set out and expressed, do each hereby GRANT, REMISE and RELINQUISH unto NORTHERN MATURAL GAS COMPANY, a Delaware corporation, its successors or assigns, the RIGHT, PRIVILEGE and EASEMENT to construct, maintain and operate pipe lines, and oppurhenances thereto, over and through the following described leads and appurhenances thereunto belonging, including rigation rights, situated in the County of the Society of Nebraska, to-wit:

South One Half of the Southwest Quarter (S25W4) Section Three (3) Township Seventeen (17) Range Five (5)

TO HAVE AND TO HOLD unto said NORTHERN NATURAL GAS COMPANY, its successors and assigns, so long as such pipe line, and apparls nances thereto, shall be maintained, together with the right of ingress to and egress from said premises, for the purpose of constructing, repairing, maintaining and replacing the property of the grantee located thereon, or the removal thereof, in whole or in part, at the mill of its grantee; it being the intention of the parties bereto that grantor s are hereby granting the uses herein specified without divesting grantor, of the rights to use and criply said above described premises, subject only to the right of the gruntee to use the same for the purposes herein expressed.

As a further consideration for this grant, the grantee herein agrees as follows:

(3) That it will bury all pipe laid upon said land to a sufficient depth so as not to interfere with the cultivation of the sail.

(2) That it will pay to grantor s any damage which may arise to growing crops, trees, shrubbery, fences or buildings from the construction, maintenance or operation of said pipe lines, said damages, if not mutually agreed upon, to be ascertained and determined by five disinterists, persons, one of whom shall be appointed by the grantors, one by the grantee, and the third to be selected by the two appointed as aforesaid, and the written award of such three persons shall be final, conclusive and binding upon the parties hereto.

(3) That grantee, upon written application by the grantor s will make, or cause to be made, a tap in any gas pipe line constructed by grantee show described premises only. All connections required, with the exception of the meter, which is to be furnished and oncome by grantee, shall be furnished and paid for by grantors according to the rules and regulations of the grantee. Said tap will be provided by grantee, and for use upon the furnished and paid for by grantors according to the rules and regulations of the grantee.
