The LOUP RIVER PUBLIC POWER DISTRICT, a public corporation and political subdivision of the State of Nebraska, pursuant to an Agreement of Lease-Purchase executed on November 6, 1968, between the parties, and in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, received by the Assignor, does hereby sell, assign, transfer and set over to the Assignee, NEBRASKA PUBLIC POWER DISTRICT, a public corporation and political subdivision of the State of Nebraska, all of its right, title and interest in and to all easements for electric lines and consent to remove and trim trees on the Kramer-Beatrice-Humboldt 115 KV Transmission line, which easements are more particularly described in Exhibit A-3 and situated in Gage County, Nebraska, hereto attached and particularly made a part hereof, which easements were obtained by assignment from Nebraska Public Power District dated August 26, 1966 and recorded December 15, 1966 at Book 41 Pages 288 et seq. of Miscellaneous Records in the Register of Deeds office, Gage County, Nebraska.




