SUZUKI AND YURIKO SUZUKI, TRUSTEES OF THE SUZUKI REVOCABLE LIVING TRUST DATED MAY 3, 1999**, hereinafter "Grantee", the following lands and property, together with all improvements located thereon, lying in the County of Story, State of Iowa, to-wit:
