PERMANENT SEWER EASEMENT

That said Grantors in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, to Grantors in hand paid by said SID, the receipt whereof is hereby acknowledged, does or do hereby grant, sell, convey and confirm unto said SID and City and their assigns forever, the right to use, construct, build, lay, maintain, repair and reconstruct a sanitary or storm sewer pipe or both for the passage of water and sewage, together with all appurtenances, wires, lines, poles, structures, and other applicable equipment pertaining to any sewer, in, through, over and under the parcel of a described as follows, to-wit:

A 40 foot wide permanent sewer and draininge easement 10 feet left and 30 feet right of the following described centerline in the N1/2, NW1/4 of Section 19, T14N, R12E of the 6th P.M., Sarpy County, Nebraska, more particularly described as follows:

Commencing at the Northeast corner of the NW 1/4 of said Section 19; thence S0°15'35"W (assumed bearing) along the East line of the NW 1/4 of said Section 19, a distance of 670.03 feet to the point of beginning; thence N77°00'54"W, a distance of 2579.91 feet to a point of termination on the South right-of-way line of Giles Road, said point of termination being N88°41'44"E along the North line of the NW 1/4 of said Section 19, a distance of 97.91 feet and S1°18'16"E, a distance of 33.00 feet from the Northwest corner of said Section 19. (See Exhibit B attached hereto and made a part hereof.)

No buildings, improvements or structures, shall be placed, in, on, over or across said easements by undersigned, his or their successors and assigns without express approval of said SID and said City; provided, however, that a paved, macadam, rocked, asphalt or other hard surfaced street or parking lot, and trees, grass and shrubbery, may be installed and said easement by Grantor, his or their successors and assigns, and in the event it comes accessary to remove or replace said street, parking to, crees, grass or shrubery, in order to repair or maintain said sewer line, the amoval or repair of said street or parking lot shall be done at the expense of SID and its successors and assigns and said premises shall be restored by SID and its successors and assigns to the condition thereof before said removal or repair.
